

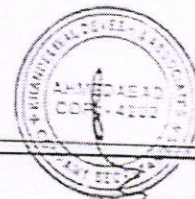

I, Devesh Khandelwal, proprietor of Khandelwal Devesh & Associates, Company Secretaries, Ahmedabad, have been appointed as Scrutinizer of **MAITRI ENTERPRISES LIMITED**, ("the Company") for the purpose of scrutinizing the e-voting process and voting by poll in a fair and transparent manner and ascertaining the requisite majority on e-voting and voting by poll carried out as per the provisions of the Companies Act, 2013 and Rule 20 of the Companies (Management and Administration) Rules, 2014 on the below mentioned resolution(s), at the 28th Annual General Meeting of the Equity Shareholders of **MAITRI ENTERPRISES LIMITED** on Friday, 27th September, 2019 at 03:00 P.M. at registered office of the company at "Gayatri House", Ashok Vihar, Near Maitri Avenue Society, Opp. Govt. Engg. College, Motera, Sabarmati, Ahmedabad - 380005.

I submit my report as under:

1. The management of the company is responsible to ensure the compliance with the requirements of the Companies Act, 2013 and rules relating to voting through electronic means (i.e. by remote e-voting and voting by poll at the AGM) on the resolutions contained in the Notice of the Annual General Meeting (AGM) of the Company. My responsibility as the scrutinizer is restricted to make a scrutinizer report of the votes cast in favor / against the resolutions stated in the notice.
2. The Company has entered into an agreement with **Central Depository Services (India) Limited (CDSL)**, the authorized agency engaged by the company to provide e-voting facilities for voting through electronic means to all the members who are eligible to take part in the remote e-voting.
3. The e-voting period remained open from Tuesday, 24th September, 2019 at 10.00 a.m. and ends on Thursday, 26th September, 2019 at 5.00 p.m.
4. The shareholders holding shares as on the "cut off" date i.e. 20th September, 2019 were entitled to vote on the proposed resolution (Item No. 1 to 5 as set out in the Notice of the AGM of the Company).



5. Accordingly the electronic votes cast were taken into account and at the end of this voting period, on 26th September, 2019 (at 5.00 p.m.) the e-voting portal was blocked for voting by CDSL.
6. The votes cast were unblocked in the presence of two witnesses Mr. Simer Singh and Mr. Yash Nayak on 27th September, 2019.
7. After the time fixed for closing of poll by the Chairman, one ballot box kept for polling were locked in my presence with due identification marks placed by me.
8. The locked ballot box was subsequently opened by me in presence of Mr. Simer Singh and Mr. Yash Nayak and poll papers were diligently scrutinized. The poll papers were reconciled with the records maintained by the Company/Registrar and Transfer Agent of the Company and the authorizations/proxies lodged with the Company.
9. I did not find any poll papers invalid.
10. After the conclusion of the Annual General Meeting of the Company, the votes cast at the meeting were counted and the votes cast through remote e-voting process were unblocked by me in the presence of two witnesses Mr. Simer Singh and Mr. Yash Nayak who are not in the employment of the Company.
11. Thereafter, the details, containing, inter-alia, list of equity shareholders, who voted "For" and "Against", were downloaded from the e-voting website i.e <https://www.evotingindia.com> Data regarding the e-voting were diligently scrutinized.
12. The register has been maintained electronically to record the assent or dissent received, mentioning the particulars of name, address, Folio No. or Client ID of the shareholders, No. of shares held by them and nominal value of such shares. There were no shares with differential voting rights in the Company; hence there is no requirement of maintaining of the list of shares with differential voting rights.
